The Regular meeting was called to order at 6:00 PM.

Student Liaison Report – Mrs. Bartlome presented the students who participate in the web program at Sailorway Middle School. Each student participated in the presentation about what the web program is and how they help incoming students feel connected and part of the building.

Legislative Report – Shelly Innes covered HB 606 which is the seizure safe schools bill. This bill is to require public and chartered nonpublic schools to create a seizure action plan for each student with a seizure disorder or epilepsy. SB 329 which authorizes certain subdivisions to designate areas within certain residential property is wholly or partially exempted from property taxation and HB 565 which would add five nonvoting members to the State Board of Education.
