HB 583 was proposed to amend section 3319.226 of the Revised Code regarding educator licenses for substitute teachers, to establish a committee on the substitute teacher shortage, and to make an appropriation. And lastly, HB 497 was proposed to amend the sections 3301.0711, 3301.163, and 3313.608 of the Revised Code to eliminate retention under the Third Grade Reading Guarantee.
