- Two (2) proofs must be brought and shown to the Registrar as stated below.
- Your name must appear on all proof of residency documents.

<b>One item for proof of residency must be from the five items listed below:</b>	
1	Rental Agreement signed by landlord and renter along with landlord contact information
2	Purchase Agreement signed by all parties closing date and letter from realtor confirming occupancy
3	Construction contract signed by all concerned parties
4	Homeowner Mortgage Statement or coupon
5	Homeowners Deed

<b>Second item for proof of residency must be from the six items listed below:</b>	
1	Homeowners insurance statement/bill
2	Property tax bill
3	Most recent pay stub with address
4	One (1) recent utility bill (electric, water, gas, cable, phone)
5	Most recent bank statement with address
6	Letter of verification of utility service (water, gas or electric)
